1. Single Sales Supply Contract Disclosure

(1) ASML Hwaseong New Campus Cleanroom Construction Contract (2025.03.06)

On the 6th, we announced through disclosure that our company has been awarded the ASML Hwaseong New Campus cleanroom construction contract. The client for this project is ASML Korea LLC, the world's largest semiconductor equipment manufacturer with unrivaled technology in the EUV (Extreme Ultraviolet) lithography equipment field. The Hwaseong New Campus that we have contracted will become a key base for ASML's business expansion in Korea. The contract amount is 7.15 billion won, which represents 1.24% of our recent sales (based on consolidated figures for 2023). Starting with this project, we will expand our business area into global projects with worldwide companies based on our advanced technological capabilities.

(2) Samsung SDS Suwon Data Center Server Room Construction Contract (2025.03.19)

On the 19th, we announced that we have been awarded the Samsung SDS Suwon Data Center server room construction contract. Recently, Shinsung E&G has been showing visible achievements related to data centers. In addition to the MOU signed with DataBean, which will be detailed in <Major News>, we have also been awarded the Samsung SDS Data Center construction contract. This project is the second project following the Samsung SDS Dongtan Data Center server room construction, with a construction amount of approximately 4.3 billion won. Based on this project, which is scheduled to be completed by the end of this year, we will diversify our business areas into high value-added new businesses.
